COURSE ABSTRACT

This course will provide an understanding of the development of the EU environmental policy and legislation, main principles and key issues within this area. The course will focus on the Treaty principles and objectives in area of environmental protection, the adopted legislation, implementation challenges and the court practice within the field of EU environmental law.

COURSE OBJECTIVES

The course consists of lectures and seminars. Lectures on a particular topic will be followed by seminars, which aim at better understanding of the topics discussed as well as developing the students' problem solving skills. For seminars students are expected to analyse materials and case-law assigned by the lecturers before particular seminars.

Students will be expected to have a good basic knowledge of general concepts of EU environmental law and policy.

COURSE REQUIREMENTS

The final grade will mainly be based on the result of written replies during the exam (on spot), which will include test with multiple choice and open questions.

NB. A consistent lack of participation in seminars (fewer than 50 % attended without justifiable reason) may constitute for a basis for either diminishing the overall course grade or (in case of 90% absence) for denying access to the final exam.

Active participation is expected from students in all seminars. Students are furthermore required to make at least one specific contribution during one of the seminars. The contribution is a short presentation or a similar task which will be assigned by the lecturers before particular seminars.

Students are expected to prepare for each seminar and participate in discussions.
