COURSE ABSTRACT

The course focuses on comprehensive approach to theory and practice of international organisations in contemporary international relations. Different theoretical approaches, which are dealing with analysis of development and activities of international organisations, will be considered and applied. Within the course, various international organisations will be examined, considering their historical origins, roles and functions, as well as international and domestic political forces that impact their working and effectiveness. International organisations are subjects of international law. In this course, the most important legal and institutional issues of the law of international organisations will be studied: legal position of international organisations, issues of membership, institutional structures, decision-making and legal instruments, dispute settlement and responsibility. Activities of international organisations in political, economic, humanitarian, social and cultural spheres will be analysed. Within the course, activities of the international non-governmental organizations will be considered by paying attention to their role, potential and limitations in international relations. International organisations to be analysed range from the League of Nations to the United Nations, from the World Bank to the World Trade Organisation, from the ASEAN to OSCE and Council of Europe and many other regional organisations.

COURSE OBJECTIVES

The course aims to explain the essence of the character of international organisations as subjects of international law and to distinguish them from the States as primary subjects of international law. The course aims to give students an understanding of the major theoretical, legal and empirical aspects of the role of international organisations in international politics, including their impact on the practice of international cooperation and conflict, the maintenance of international peace and security, the management of international economic relations, the promotion of international environmental standards and related matters of concern to internationals society.

COURSE OBJECTIVES

- Students understanding the history and the importance of international organisations.
- Students have revised the necessary theoretical knowledge for analysing of the role, functions and aims of the international organisations.
- Students understand legal position of international organisations.
- Students acquire more specific knowledge about validity of legal instruments and hierarchy between the Acts.

Skills:

- Students have improved skills in carrying out analysis of case-law and judicial findings.
- Students have improved argumentation and writing skills.
- Students have improved skills of analytical approach to international politics.
- Students have improved skills of applying theoretical knowledge about international organisations and their role in the international environment.
- Students will improve legal research skills.
